

### OFFICIAL RULES FOR COMPETITION

Symphony North, Inc. 2024 – 2025

27<sup>th</sup> Annual Young Artists Competition

# I. Eligibility

SYMPHONY NORTH

A. Age – This competition is open to students who are 19 years old or younger during the 2024-2025 school year.

B. Location – Symphony North, Inc. serves the Greater Houston Metropolitan area; therefore, we require the applicant to live or study in the Greater Houston Metropolitan area, including Harris County, Texas, and the surrounding contiguous counties.

C. Category —The judge(s) may select up to three category winners from any of the orchestral music disciplines who are selected to compete at the finalist competition. The available categories are strings, winds, piano, and percussion. The category winners who are selected at the finalist competition will then perform with Symphony North at its Young Artist Competition concert. At the concert an overall winner will be selected from among the category winners.

D. Music – An applicant may submit one movement of a classical concerto work, or a similarly challenging popular work of music pending the availability of the music and feasibility of performance as determined by the active music librarian of the orchestra, in conjunction with available libraries maintained and made available to us by our partners and collaborative associations within our community. Preapproval of the selection is not necessary.

E. Previous Winners – This is an annual competition – category winners of the prior year's competition shall be ineligible to enter the subsequent year's competition but would be eligible to enter the following year's competition (i.e. after the one-year ineligibility period), subject to all other qualifications of entry.

#### II. Procedure

A. Complete an online application at <a href="https://yac.symphonynorth.org/">https://yac.symphonynorth.org/</a> and submit a non-refundable entry fee of \$35, which is also payable online. The deadline for completing the online application and entry fee must be submitted by Saturday, January 18, 2025, midnight CST.

B. The video URL or link to the digitally stored recording on a server or video

platform of the concerto movement must be included with the online application. The recording must be of the applicant's performance accompanied by a pianist or orchestra.

From these digitally stored recordings, a group of category finalists will be selected by a judging panel comprised of not less than three or more qualified judges. Only finalists will be notified of this decision. [NOTE: It is to your advantage that your URL points to a HD (1080p or 4K) digital recording. For the recording, if you use a stereo recorder, place the soloist and accompanist on separate channels. If you use a monophonic recorder, place the soloist much closer to the microphone than the accompanist.]

C. Finalists will audition before a duly qualified judge's panel on **Saturday, February 15, 2025**, at the Moores School of Music Dudley Recital Hall on the main campus of the University of Houston. Performance times to be scheduled in twenty (20) minute increments beginning at 9:00 a.m. and ending by 12:00 p.m. (noon). Each finalist will be scheduled for an audition performance and should plan to arrive at least 20 minutes before their scheduled performance time. Rehearsal rooms will be available to tune, warm-up, or to otherwise become acclimated to the venue and prepare. **Auditions must be performed with a piano accompanist, who is to be provided by the finalist.** No less than three (3) copies of the solo with piano accompaniment, with measure numbers marked, must be provided for the judge's panel.

Should a chosen finalist fail or refuse to perform for any reason, the next ranking finalist will be elevated to that finalist's placement.

## III. Performance

Winners will perform with Symphony North of Houston at their Late Spring Concert on **Sunday, May 18, 2025.** The winners will be required to be in attendance by 2:45 pm for a 3:00 call and 4:00 performance at Salem Lutheran Church, 22601 Lutheran Church RD, Tomball, TX 77377. Rehearsals will also be at Salem Lutheran Church on Monday evenings at 7:30 pm.

If selected as a category winner, the following rehearsal dates are mandatory and attendance is required (when practicable, winners will be rehearsed at the earliest possible time during these rehearsals):
